Credit Card Payment Authorization Agreement

Sabin Robbins is pleased to offer its customers the convenience of paying for their purchases by credit card. This agreement establishes customer's and cardholder's ongoing authorization for Sabin Robbins to process payment for new or outstanding purchases via charge to the credit card listed below. Customer and cardholder (if different) shall be jointly and severally liable for all valid charges to the credit card specified below.

Execution of this agreement does not create a credit availability for customer with Sabin Robbins. Customer must apply for credit with Sabin Robbins separately (that process is initiated by submitting a completed Credit Application and Purchasing Agreement).

Customer agrees to forgo Sabin Robbins' terms discount in exchange for the convenience and benefits of settling its purchases via credit card charge. **Acceptance of credit card payment of invoices aged beyond the expiration of the terms discount requires prior, specific authorization from Sabin Robbins.**

This agreement will remain in force until customer or cardholder provides written notice to Sabin Robbins of desire to cancel this agreement as it relates to any future purchases. Customer and cardholder agree that both new purchases and credit card charges may arise from orders and instructions given to Sabin Robbins by mail (including e-mail), fax, phone, or direct personal contact.

Title to goods purchased shall be retained by Sabin Robbins until paid for in full, including all finance and service charges.

Customer and cardholder agree that any disputed charge, or request for chargeback or adjustment, will first be reported to Sabin Robbins before any other action is taken. Sabin Robbins is committed to customer satisfaction.

Should customer or cardholder fail to fulfill any of its respective obligations under this agreement, Sabin Robbins may declare any existing balance due and immediately payable, and may proceed to enforce the full payment of such balance, including finance and service charges. In event of suit to collect such balance, customer or cardholder shall pay all of Sabin Robbins costs and expenses of collection, including reasonable attorney fees and actual court costs.
